

Libby Man Dies In Train-Car Collision

LIBBY — Lincoln County's traffic safety record was snapped at 2 a.m. Sunday with the death of Curtis D. Sandau, 27, Libby, at a grade crossing four miles north of Libby.

Sandau was instantly killed when his vehicle was struck on a grade crossing of the Great Northern Railway by a west-bound freight train. George Johnson, Whitefish, was engineer of the train. Sandau's car was knocked 87 feet from the crossing by the impact.

He was a veteran of World War I having served in the U. S. Army from July 1918 until July 1920. In August of 1923, he re-enlisted in the U. S. Army where he served until July 1926. He returned to the Flathead Valley and was again engaged in logging work. He had been a resident of the Montana Veterans Home in Columbia Falls for a time and was making his home at the Kalispell Hotel at the time of his death.

Mr. Sansevere is survived by one sister, Mrs. Lucille Madole of Whitefish and several nieces and nephews.

John Fisher conducted the investigation of the fatal crash with investigation still being kept open at this time. An inquest is not likely. Deputy County Coroner Mel Vial attributed cause of death to massive, multiple fractures. Sandau's body was found in the wreckage of his demolished car.

Johnson told patrolmen the engine horn was sounding for the private crossing leading to a group of cabins from the St. Regis Co. road. Johnson dynamited the train brakes in an effort to slow the freight before the crash. The train was halted for about two hours while authorities completed their preliminary investigation and then proceeded on its route.

The head end crew of the freight had the impression Sandau was trying to beat the train across the crossing.

Sandau's body is being forwarded to Jamestown, N.D., for funeral services and burial.

He was single and is survived by his parents, Mr. and Mrs. Reinhold Sandau at Jamestown; three sisters, Mrs. Lucille Wiley, Libby; Mrs. Helen Ness, Washburn, N.D., Miss Della May Sandau, Portland, Ore., and two brothers, Gordon, Libby, and Charles, Vietnam.

Sandau was a four-year veteran of the Vietnam war.

His death is the first in Lincoln County this year. It snaps a 74-day safe driving skein in Lincoln County.

truck was struck by the Scott car.

Admitted to St. John's Hospital were Scott and his son Buddy. Scott is considered by hospital attendants as being in serious condition. Tony and Jessie were treated for minor injuries and released. Buddy was held in the hospital for observation.

Both vehicles were extensively damaged. The investigating patrolman has requested an inquest be called. Decision on that is pending according to County Atty. Bill Douglas.

Mrs. Scott's death was the second traffic fatality of the year in Lincoln County. It also snapped the best safe driving string in Northwest Montana at 85 consecutive days.
