Longtime radio broadcaster Willard L. "Bill" Holter, 81, passed away peacefully at Lake View Care Center	
in Bigfork on Tuesday March 15, 2005, due to complications from Parkinson's disease.	

Holter was well known in the radio industry across the state, having owned stations in Helena, Glasgow, Malta, Missoula, Livingston and Great Falls. He was also a respected leader in politics as chairman of the state Republican Party and Montana delegate to national conventions in 1968 and 1972.

Bill was the 2002 inductee into the Montana Broadcasters Hall of Fame. He was honored for improving the quality of radio and involving stations in their communities. 


