Legal Advisory Board Formed to Aid Registrants

At a meeting of the local bar association last evening in the office of County Attorney D. Gordon Roggen, a legal advisory board was organized to assist registrants under the selective service act in filling out their questionnaires. The board is a voluntary organization for the purpose of cooperating with the local draft board on the prompt remittance of questionnaires.

It was recommended by the board however, that registrants make every possible effort to fill out their own questionnaires as far as possible before calling for any legal aid. In many cases legal assistance will probably not be required, it was pointed out.

Persons having difficulty in filling out their questionnaires will have lawyers assigned to them for assistance by Chief Clerk Ellis S. Diekey.

"Attorneys of the county will assist registrants in any reasonable way without charge," Mr. Roggen said. "It is urged, however, that registrants make every effort possible to complete the questionnaires themselves rather than burden local lawyers with minor details."

Among questions which registrants will probably find difficult to handle without legal advice are those regarding exemptions.

Classification of Registrants to be Started This Week

Classification of registrants under the selective service act will start this week by the local board, Chief Clerk Ellis S. Diebold as an increasing number of questionnaires are being returned daily.

According to regulations of selective service act, classification will fall into four groups: Class 1, those who are physically fit and have no dependents; Class 2, married without dependents other than 11 wives; Class 3, those with several dependents; and Class 4, the physically disabled.

It was pointed out, however, that it will be several weeks before a call is made from Flathead county. No call will be made from this county during November and officials expressed doubt if there would be a one taken from the county during December. It is quite possible that there will be no call from Flathead county until after the first of the year. Applications of five volunteers are already on file at the draft board office and if all qualify for military service, this group may fill the Flathead county quota.

Mr. Dickey requested that registrants filling out questionnaires do so in ink. This, he said, is required and the rule should be closely observed by the registrant.

FLATHEAD COUNTY MEN MAY NOT BE CALLED TO SERVICE BEFORE NEXT JUNE

Flathead county will not be called upon to furnish men through the local draft board under the selective service act before June 30, 1941, according to advice received today by the local board. The plan to exempt Flathead county from a call for men is tentative, however, it was pointed out.

Reason for the delay in calling men from this county was attributed to the large number of registrants who have enlisted in some branch of the military service since October 16 and the credit received by the county for its national guard enlistments.

It was pointed out by the board, however, that this order has no bearing on the immediate return of questionnaires sent out to registrants. Questionnaires must be returned within five days after they have been mailed.
