# Leslie Green is Shot To Death Today in Gun Fight Near Cedar Lake

CHARLES MURE, ALLEGED SLAYER, DISAPPEARS IN THE WOODS FOLLOWING TRAGEDY—BURNING OF CABIN LEADS TO FATAL ROW — SHERIFF ROBINSON AND DEPUTIES START SEARCH FOR MURE

Leslie A. Green, town marshal at Columbia Falls, was shot and killed this morning about 11 o'clock near Cedar Lake, seven miles north of Columbia Falls, by Charles Mure, alias Charles Ayers, it is reported by Tom D. Caverly, justice of the peace, who witnessed the shooting.

#### Mure Arrested

A telephone message from Columbia Falls to the sheriff's office this afternoon, stated that Mure was arrested in a shack near the railroad tracks in Columbia Falls by a special deputy by the name of Kautsen, shortly after 3 o'clock, He is in jail at Columbia Falls, pending pending removal to the county jail here.

The trouble arose over the hurning of a cabin belonging to Clarence Firestone, who charged Mure with the offense in justice court. Justice Caverly and Marshal Green drove to Cedar Lake this morning to investigate, and questioned Mure and Ray Brown, who had been occupying the cabin. Mure, it is said, admitted that he had had some trouble with Firestone. The stories of the two men did not agree, and after a consultation it was decided to take them to Columbia Falls for further questioning, but not to place them under arrest. Caverly went to notify Brown, who was some distance away and had proceeded about 100 yards, when he heard three shots, and turning saw Green and Mure "blazing away" at each other. He started to Green's assistance, but Mure started running through the thick underbrush, pursued by Green. He heard a number of other shots, and estimates that both men had emptied their guns twice. Following the sound of the shots, he called to Green, who answered once from the thick brush, but Mr. Caverly did not see him until he came upon his body lying where it had fallen, his gun cocked. Mure had disappeared in the woods.

### Caverly Notifies Sheriff

Mr. Caverly returned to Columbia Falls and notified Sheriff Robinson, who with Deputies Adams and Yuili immediately started a search for Mure in the woods north of Columbia Falls.

Green was a brother-in-law of Sheriff Robinson, and is survived by (Continued on Page 8)

(Continued from page 1) his wife, three sons and a daughter.

It is a peculiar circumstance that this is the second Columbia Falls officer who met death in almost the same manner.

On April 19, 1931, Marshal Jake Neitzling with two Great Northern special agents, went to the cabin of Donald Frazier, who lived a short distance north of Columbia Falls, to question him regarding the piling of ties on the railroad track near Coram. When Neitzling approached the cabin he asked Frazier to come out, and the answer was a bullet from a .38 caliber revolver, which struck the officer in the head, killing him instantly. When county officers arrived an hour afterward they found that Frazier had committed suicide with the same gun that had killed Neitzling.

## ROBERT GREEN IS KILLED WHEN CAR HITS PARKED TRUCK

The first fatal automobile accident in Flathead county this year occurred about 10 o'clock Saturday evening when Robert Green, 25, of Coram was instantly killed when he crashed into a parked truck on Highway No. 2 about 15 miles northeast of Kalispell. Selly Ford who was riding with Green escaped with minor cuts and bruises,

Leland Carrie and Van Elliot, owners of the truck, were repairing a flat tire and were purked at the side of the highway with flares burning 175 feet from both directions and lights of a car belonging to W. J. Sandusky burning at the rear end of . their machine.

The Green machine, it was reported, hit the left rear end of the truck, the platform barely missing the hood and shattered timbers from the body and platform of the truck crashed through the windshield of the car crushing Green's head and breaking both arms.

After striking the truck the car carcened along the road for more than 50 feet before tipping over and : then slid for a distance of about 125 feet on its side.

Green was coming toward Kalispell at the time of the fatal accident and it was stated that he was driving at a rate of speed of about 80 miles an hour. It is thought possibly that he mislook the flares as warning for the Saudusky machine and swung back onto the right side of the road after passing it. The Samlusky ear. . was parked several feet back of the truck.

The truck had developed the flat tire earlier in the evening and Carrie and Van Elliot had gone back to Coram for flures. They had been working only a short time on the stalled truck when the accident occurred. A few minutes before the futal crash Jack Bessant of Kalis-. pell had passed the truck and testified at the preliminary investigation made by Highway Patrolman Ray Biyan that both flares were burning , and that the lights of the Sandusky car were on,

Green has been operating a sawmill in partnership with his father and brother near Coram.

Funeral services have been announced for Tuesday afternoon at 3:30 o'clock from the Waggener & Campbell chapel, Rev. F. B. Hillis i officiating. Burial will be made in the Courad Memorial cemetery.
