**HEART ATTACK FATAL FOR FRANK THOMPSON**

Frank Thompson, Great Northern brakeman, died of a heart attack Wednesday night at Spotted Bear. Accompanied by his nephew, Newton Olson of Fort Peck here on a vacation trip, Thompson left for the South Fork country on an elk hunt. Reports indicate the hunters had gotten only as far as Spotted Bear. A telephone message asked that a doctor be sent to Spotted Bear at once as Thompson was very ill. Before arrangements could be made to send a doctor, another message came, saying: "Never mind the doctor; Thompson is dead." The ambulance left at once to bring in the body.

As far as was known, Thompson was in excellent health when he left on the hunting trip, and he and his nephew were anticipating a 10-day stay in the elk country of the South Fork. They had had a successful fishing trip the last of the week before and were looking forward with high anticipation to the elk hunt.

Thompson has served the Great Northern since May 5, 1916. He is survived by a son, Leonard Thompson of the U. S. Navy, a daughter, Mrs. Joe Laux, the former Francine Thompson, who resides in Kalispell. —Whitefish Pilot.
