# Whitefish Boy Shot At Missoula Today, Died Immediately

Missoula, March 20.—(P)—Robert Rooney, 21, Montana State University junior, White-fish, was killed instantly early this morning by a buffet from a 270 caliber rifle fired, County Attorney Edward Dussault said, by Sylvester C. (Ole) Ward, 46-year-old World war veteran.

The shooting occurred in front of Ward's home in an outlying district of the city, after Rooney, Ward and George Cruig a fellow student, had gone to the home from a downtown beer parior. The two students had met Ward, then gone with him in a fast to the home, Dussault said.

Dussant said Craig told them they had been in the house a few minutes and that they were leaving and had reached the gate in front of the house when Ward came out with a rifle in his hand.

Rooney was talking to Ward in an attempt to get him back into the house when the fatal shot was fired. Dussault said, Craig told him.

Officers said Ward told them later this morning he fired in self-defense, claiming there had been a struggle. The shot pierced the heart of the victim, causing immediate death, country officials said.

An inquest will be conducted at 1:30 o'clock Saturday afternoon, Coroner Ella M. Stucky said today. County 'Attorney Dussault said no formal charges will be filed, pending results of the inquest, Ward is being held at the county jail,
