**Frank Safford is  
Suicide Victim;  
Ends Life Tuesday**

Frank Safford, 50, a World War veteran, was found dead late last night in the back room of the Mission Motor Inn, where he was employed as a bookkeeper, following a search made by officers at the request of Mrs. Safford when he failed to appear at home for his meals.

Mr. Safford had taken his own life and a .45 Colt's automatic, which was identified as his own, was found by his side. The body was slumped behind a counter stored in the room and officers said it is quite probable he had been there for 12 hours or more.

It is understood he left home in the morning for work and when he failed to appear home for luncheon Mrs. Safford made several inquiries in an effort to locate him. When he failed to come home for dinner, a more extensive search was made, but it was not until nearly midnight that a searching party composed of Ted Homan, his employer, Sig Ludwig and Police Officer Ray Kent conducted the search of the building.

Despondency is assigned as the cause, as he had been in ill health for some time.

Before coming to Kalspell he resided in Great Falls.

He is survived by his widow, eight brothers and sisters and his father. His father and brothers and sisters live in Wisconsin and have not yet been contacted. Funeral services have not yet been announced, but it was stated the American Legion will be in charge. The body is at the Waggener and Campbell parlors.

## Coram Man Takes Own Life at His Ranch Yesterday

James A. Stevens, aged 30 years, of Coram, early Monday afternoon took his own life with a .32 calibre revolver at his ranch home about a half mile east of Coram. Coroner Harry H. Campbell reported this morning. Mr. Campbell said it was a clear case of suicide and that no inquest would be held.

According to Mrs. Stevens, her husband had sent her on an errand to a nearby store and when she returned she found him lying on the floor of a workshop about 200 feet from their home. He had shot himself through the mouth with the pistol.

It was stated Mr. Stevens had been suffering from ill health for some time which fact was probably responsible for his decision to take his own life.

In addition to his widow and small daughter, he is survived by a father living in Missouri. Funeral arrangements have not yet been completed.

### Harlem Man is Killed in Truck Accident, Essex

George M. Stow, Jr., 40, of Harlem was crushed to death about 8 o'clock Tuesday evening on highway No. 2 east of Essex when 8,000 feet of green lumber tipped over onto the cab of his truck. Coroner Harry H. Campbell and highway patrol officers, together with men and equipment from a local garage, worked until 2 o'clock this morning to extricate the body, cutting away both doors and applying pressure jacks inside the cab.

Rex Farrer, also of Harlem, who was riding in the cab with Stow, miraculously escaped injury, but was pinned in the machine for several hours before being released.

According to Coroner Campbell's report, Mr. Stow was driving a semi-trailer truck and had applied the trailer brakes on a downhill slope just east of Essex. The trailer swung at a right angle to the truck, smashing guard railing and tipping the load of lumber over on the truck.

Mr. and Mrs. Ralph E. Snow of Essex had parked their car along the guard rail at the approach of the heavily loaded truck and the front of their machine was crushed when the trailer tipped over. Because of the slippery condition of the incline on which they were parked, it was impossible for them to back up to escape. Neither was injured, however, although escaping death only by inches.

Mr. Stow had purchased a load of lumber at the Johnson sawmill northeast of Kalispell and was returning home when the accident occurred.

Stow is survived by a widow and the body is now at the Waggener & Campbell funeral home pending funeral arrangements.
